#### **Permanent Licence Application**

18<sup>th</sup> November 2008. That was the deadline for applications to be submitted to Ofcom for the latest round of community radio licenses. Since August 2006, Ofcom have been advertising community radio licenses on a regional basis. The penultimate area, East and SE England, is the area we fall under. The final area to be advertised is Greater London.

So after a great deal of work by a lot of people, Redstone FM has completed its licence application and it was duly handed to an Ofcom official on Monday 17 November – along with 10 appendixes of supporting documents. Now we wait! We don't know how long Ofcom will take to assess the applications for this region but at some point we do expect them to ask supplementary questions to clarify points in our document. This is a standard procedure with Ofcom.
